Dear Valued Patron:

**Safety** We have enclosed a brochure for you to read and share the information with everyone living in your household. Your safety is extremely important to us.

**DRIVER SAFETY:**

Please provide a path to the tank that is FREE of DEBRIS and SNOW to avoid non-delivery

The PROGRAMS below apply to customers who have a 250-gallon tank or larger.

**Summer-fill:**

Call your order in by July 24, 2026. Your tank must be able to hold **150** gallons or more.  
**Summer-fill price is \$1.49** Cash price.

**Budget Plan:**

Enroll TODAY to budget your heating expenses. Propane will be billed at the charge price. Monthly payment amount will be determined by averaging a 2-year history. Call the Brooks Office for more information on this program 218-698-4271.

**Prepay Price Contract:**

The contract needs to be received and paid for by August 31, 2026. Contract enclosed.  
**Prepay Contract price is \$1.79 (while gallons are available)**. Once your contract and payment are received, your gallons will be locked in. Deliveries will begin October 1, 2026, and will end April 30, 2027. You are required to use all contract gallons first. No exceptions. It is best to contract early to ensure gallons are available. **Contract prices may increase once gallons run out.**

**Route Delivery:**

A program that helps assist you so that your propane supply is uninterrupted. This program is designed for full-time heat sites. If your home or business is seasonal, a tank monitor is required.

- 1) Customers must still check the tank
- 2) Red Lake County Co-op is not responsible for outages
- 3) Route fill customers are strongly encouraged to have a tank monitor
- 4) If an account is "past due" route delivery is discontinued
- 5) Red Lake County Co-op is NOT responsible for damages due to outages.

**Tank Monitor:**

A tank monitor can be placed on your tank to avoid outages. Monitors allow you to see the percentage in your tank and can be accessed through a cell phone app. Contact 218-681-3436 to schedule your monitor installation.



### Will Call Delivery Policy:

- 1) Call orders in around 30%
- 2) Give a three “business” day notice to get order scheduled for delivery
- 3) Outages or special trips will be an extra **\$200**

### Outage Policy:

- 1) Leak check is required on the system.
- 2) Customer needs to be at residence when driver performs leak check.
- 3) There is a **\$100** charge.

### Cash Accounts:

Customers who have a cash only account will need to have delivery paid BEFORE a truck is dispatched. Keep in mind that we need a notice of **three** business days to work the delivery onto our routes. Payment can be made online at [rlccoop.com](http://rlccoop.com) or brought into the office. Payments are no longer accepted over the phone.

### Gas System Checks:

We will be conducting Gas System Checks per our Insurance requirements. If your tank is due for checks and Regulator updates, we will be contacting you for an appointment to come and check your Regulators and do a System Leak Check to avoid interruption of service.
